Re: Thank You for the €14,000 Contribution – Mobile Honey Testing Unit

On behalf of the entire Nzatu team, I would like to sincerely thank Afro Med and all those who contributed towards the mobile honey testing unit initiative.

We are pleased to share an update on what your contribution has helped us achieve. Following receipt of the €14,000 contribution, we have now acquired a second hand 2021 Isuzu D-Max in South Africa. The vehicle was purchased for R350,000, equivalent to approximately €18,875.

The Nzatu founding members agreed to contribute a further €4,875 towards the purchase. We felt it was important to add the difference so that we could acquire a more suitable and robust vehicle capable of serving not only the mobile honey testing unit, but also the wider needs of the programme and the communities we work with. Nzatu has also covered the vehicle import duty of US\$3,684.

We believe the Isuzu D-Max will be a valuable workhorse for Nzatu. It will allow us to reach our communities more effectively, transport equipment and supplies, and support the movement of honey and other agricultural produce as the programme grows.

We are currently fabricating a workbench to be fitted to the rear of the vehicle, which will allow us to carry and organise the equipment required for field activities. Further down the line, we also intend to acquire a trailer that can be attached to the tow bar, allowing us to transport larger quantities of honey and other produce.

The vehicle therefore forms an important part of the wider mobile laboratory infrastructure, while also becoming a valuable field asset for Nzatu. It will allow us to reach communities more effectively, carry the necessary equipment and support the collection and movement of produce as the programme grows.

We are particularly grateful to Afro Med for helping us take this important first step towards making the mobile honey testing laboratory a reality. We will continue to share updates of the operation.

Thank you once again to Afro Med and all the donors for your generous support and confidence in Nzatu.
